APPROPRIATION ORDINANCE NO. 12-18
Series of 2012

AN ORDINANCE AUTHORIZING THE ANNUAL BUDGET OF THE 20% COMMUNITY DEVELOPMENT FUND OUT FROM THE INTERNAL REVENUE ALLOTMENT OF THE MUNICIPALITY OF VALENCIA, BOHOL FOR FISCAL YEAR 2013 IN THE AMOUNT OF TEN MILLION FIVE HUNDRED SEVENTY NINE THOUSAND SEVEN HUNDRED THIRTY PESOS AND 20/100 (PHP10,579,730.20) FOR FISCAL YEAR 2013, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE

Be it ordained by the Sangguniang Bayan in session assembled, that:

Section 1. **Annual Budget.** The Annual Budget of the 20% Community Development Fund from the Internal Revenue Allotment of the Municipality of Valencia, Bohol for Fiscal Year 2013 in the amount of **Ten Million Five Hundred Seventy Nine Thousand Seven Hundred Thirty Pesos and 20/100 (Php10,579,730.20)** that funds various development projects of the municipality are hereby approved.

The budget documents consisting of the following are incorporated herein and made integral part of this Ordinance:

1. Budget of Expenditures and Sources of Financing
2. Annual Investment Program
3. MDC Resolution

Section 2. **Sources of Funds.** The sources of funds for the Annual Budget of the 20% Community Development Fund shall be as follows:

20% of the Estimated Internal Revenue Allotment for 2012	P10,579,730.20
Total Sources of Funds	<u>P10,579,730.20</u>

Section 3. **Use of Funds.** The amount of **Ten Million Five Hundred Seventy Nine Thousand Seven Hundred Thirty Pesos and 20/100 (Php10,579,730.20)** are hereby provided for the following expenditures:


1. Loan Repayments-Construction of Badiang Springs Hotel	P2,500,000.00
2. Badiang Resort Multi Purpose Building	1,000,000.00
3. Fencing of MPPB (MCTC Site)	850,000.00
4. Construction of MPPB (Senior Citizens Bldg.)	1,000,000.00
5. Valencia Tech-Voc School Stairways (3-storey bldg.)	600,000.00
6. Concreting of Roads, Canmanico-Omjon Road	2,000,000.00
7. Concreting of Roads, Loctob to Lantang	1,500,000.00
8. Concreting of Roads, Cutcutan to Pangian	500,000.00
9. Other Development Projects	<u>629,730.20</u>

Section 6. **Separability Clause.** If, for any reason, any Section or provision of this Appropriation Ordinance is disallowed in Budget Review or declared invalid by proper authorities, other Sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.


Section 7. **Effectivity.** The provisions of this Appropriation Ordinance shall take effect on January 1, 2013.


